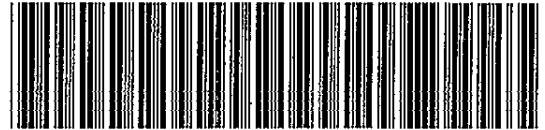

ARTICLE I: NAME

The name of this Corporation shall be:
