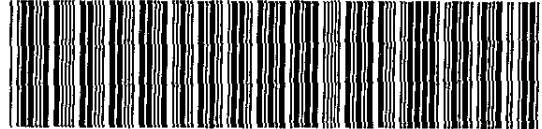

THE NAME OF THIS CORPORATION SHALL BE:

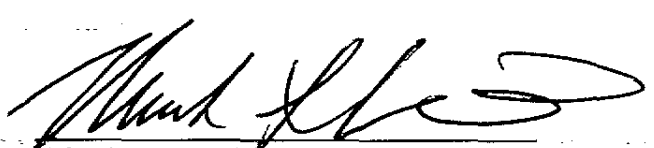
