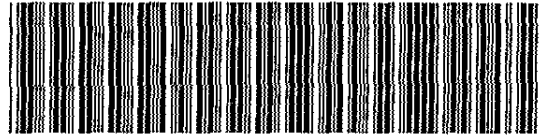

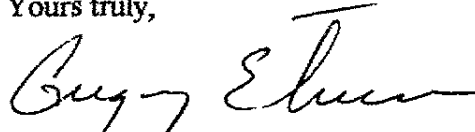

Name

The name of the corporation is QUALITY TILE OF CENTRAL FLORIDA, INC.

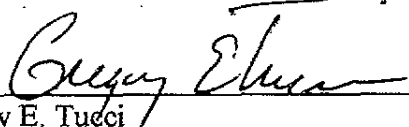
