### ARTICLES OF INCORPORATION

# OF

## WALTER WILSON SERVICE, INC.

The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

## ARTICLES I: NAME OF THE CORPORATION

The name of the corporation is **WALTER WILSON SERVICE**, **INC.**, hereinafter referred to as the "Corporation".
