After talking to someone at the Department of State about this situation, they said to go online and print a annual report and mark the box that said no notice received, sign and mail with a check for 150.00. We did exactly what they said, except the check was made out for 150.00, but was written for "one hundred"(see attached). The check was cashed for 100.00, not the 150.00. My bookkeeper, Elaine Cox, spoke with someone in the reinstatement section and explained what had happened. She told Elaine the letter of rejection was sent regarding the 50.00 that was still owed. The rejection letter has never been received. A letter as written on January 21, 2005 (attached) along with the 50.00 check to reinstate the corporation.
