GLOBAL EDGE TECHNOLOGY INC.**


Pursuant to the provisions of Sections 607.1402 and 607.1403 of the Florida Business Corporation Act, **GLOBAL EDGE TECHNOLOGY INC.**, a Florida corporation (the "Corporation"), hereby files the following Articles of Dissolution for the purpose of dissolving the Corporation:

1. The name of the Corporation is: **GLOBAL EDGE TECHNOLOGY INC.** The Document Number of the Corporation is P03000141361. The filing date of the Articles of Incorporation of the Corporation was November 26, 2003.
2. The dissolution of the Corporation was authorized by the sole Shareholder of the Corporation by written consent dated as of December 29, 2016. The number of votes cast for dissolution was sufficient for approval.
3. The net assets of the Corporation remaining after the winding-up of the Corporation have been distributed to the sole shareholder of record.
