

ARTICLES OF INCORPORATION of VAN MARTIN'S HOME IMPROVEMENTS, INC

ARTICLE I - NAME AND LOCATION OF PRINCIPAL OFFICES

STORING AN SO The name of this corporation is: VAN MARTIN'S HOME IMPROVEMENTS, INC. with initial principal offices located at 11370 U.S. 1 North, St. Augustine, FL 32095.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of these Articles with the Department of State.


