**ARTICLES OF INCORPORATION
of VAN MARTIN'S HOME IMPROVEMENTS, INC**

ARTICLE I - NAME AND LOCATION OF PRINCIPAL OFFICES

The name of this corporation is: VAN MARTIN'S HOME IMPROVEMENTS, INC,
with initial principal offices located at 11370 U. S. 1 North, St. Augustine, FL 32095.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of general home improvements or of engaging in any other activity or business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue One hundred (100) shares of stock with the par value of One and no one-hundredths dollars (\$1.00) per share, which shall be designated as "Common Shares".

ARTICLE V - PRE-EMPTIVE RIGHTS

ARTICLE VII - TAXING STRUCTURE OF CORPORATION

This corporation elects to become a small business concern under Subchapter "S" of the Internal Revenue Code of 1978.

ARTICLE VIII - CORPORATE DIRECTORS

This corporation shall have one (1) Director constituting the initial Board of Directors, who shall serve in an advisory capacity. The number of directors may be either increased or


The corporation shall indemnify any Officer or director, or any former officer or director, to the full extent permitted by law.
