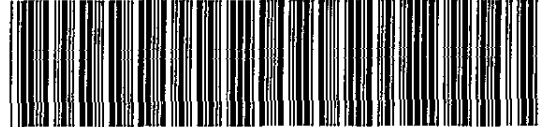

## ARTICLES OF INCORPORATION

### ARTICLE I - NAME

The name of this corporation shall be EHS Painting Inc.

### ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 6124 Olive Avenue, Sarasota, Florida 34231

### ARTICLE III - CAPITAL STOCK

The number of shares of capital stock that this corporation is authorized to have outstanding at any one time is one thousand (1000) shares at a par value of one dollar (\$1.00) per share.

### ARTICLE VII - AMENDMENT

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE VIII - EFFECTIVE DATE OF INCORPORATION

This corporation shall commence to exist on January 1, 2004, and shall exist perpetually or until legally dissolved.

ARTICLE IX - PURPOSE

This corporation is organized for the purpose of engaging in the conduct of painting and any or all lawful business, and doing all acts and things as are incidental to the foregoing purposes or necessary or convenient to carry on the business for the corporation or to effect or promote the purposes for which the corporation is formed.
