The undersigned, **James J. Bartoli**, acting as Incorporator and initial Director of a Corporation to be formed under the Florida Business Corporation Act, Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

#### **ARTICLE I**

#### CORPORATE NAME AND ADDRESS


