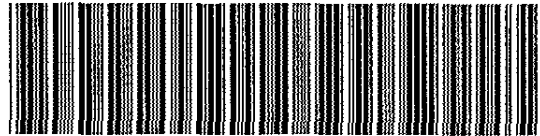



## ARTICLE IX. AMENDMENTS




