ARTICLES OF INCORPORATION
OF
PIZA GLRS, INC.

ARTICLE I - NAME

The name of this corporation is PIZA GLRS, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

ARTICLE VIII – OFFICERS




