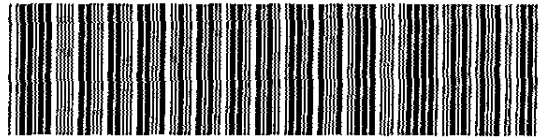

**ARTICLE I - NAME OF CORPORATION**

The name of this corporation is **CHIVARS, INC.**
