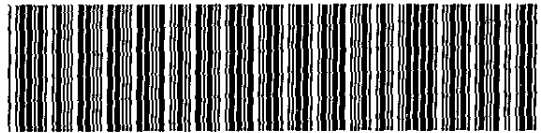

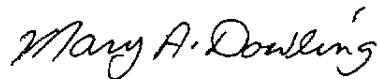

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I.

The name of the corporation ("Corporation") is **Mary A. Dowling Construction, Inc.**

ARTICLE II.

The existence of the corporation shall begin on November 17, 2003.

ARTICLE III.

The address of the principal office of the Corporation is P. O. Box 573, Glen Saint Mary, Florida 32040.
