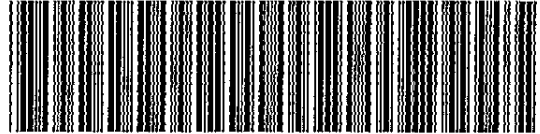

**ARTICLES OF INCORPORATION
OF
STITCHIN' STUFF, INC.
a Florida Corporation in compliance with Chapter 607, F.S.**

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida as a corporation, and hereby adopt, the following Articles of Incorporation:

**ARTICLE I
NAME**

**ARTICLE II

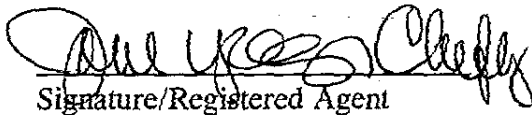

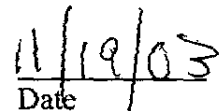

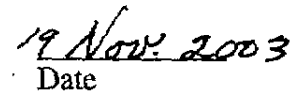
