

## ARTICLES OF INCORPORATION

SECRETARY OF STATE a Florida Corporation in compliance with Chapter 607, F.S. AHASSEE FLORIDA

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida as a corporation, and hereby adopt, the following Articles of Incorporation:

#### ARTICLE I NAME
