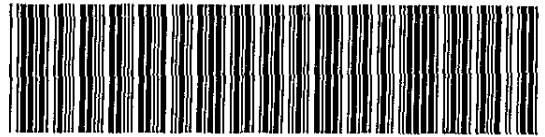

## **Articles of Incorporation for Ilen Estrada Homes Developer, Inc.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract and legally authorized to practice the profession of home developer and real estate sales in the State of Florida, hereby proceeds to form a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following Articles of Incorporation for such corporation:

### **ARTICLE I--NAME**

The name of this corporation is Ilen Estrada Homes Developer, Inc.

### **ARTICLE II--PURPOSE AND NATURE OF BUSINESS**

The purpose of the Corporation and the nature of its business are as follows:

To render the service of developing real estate and sales to the public, which shall include development, advertising, listing, promoting and appraisals of real estate. This professional corporation shall exist and function in compliance with the "Florida Professional Service Corporation Act" (F.S.A. Chapter 621) and in order to properly prosecute the objects and purposes above set forth, the Corporation shall have full power and authority to purchase, lease and otherwise acquire, hold, mortgage, convey and other-wise dispose of all kinds of property, both real and personal, necessary for the rendering of the service of developing real estate sales and anything ancillary to such business;

### **ARTICLE III--CAPITAL STOCK**

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 1,000 shares having a par value of \$1.00 per share. Such shares shall be of a single class of common stock. None of the shares of the Corporation may be issued to anyone other than an individual who is duly licensed to act as a real estate salesperson and/or broker in the State of Florida and is an active member in good standing.

### **ARTICLE IV--DURATION**

The Corporation shall have perpetual existence.

## **ARTICLE V--ADDRESS AND AGENT**

The street address of the principal and initial registered office of the Corporation is 4075 Pine Ridge Road, Suite 15 Naples, Florida 34119 and the name of its initial registered agent is Ilen Estrada. The Board of Directors may, from time to time, move the office to any other address in the State of Florida and change the registered agent.

## **ARTICLE VI--DIRECTORS**

The Corporation shall be managed by a Board of Directors of at least one (1) Director. No person shall serve as a Director of the Corporation unless the person is duly licensed to practice Real Estate sales in the State of Florida. The Directors shall be elected by the shareholders of the Corporation. The name and street address of each person who is to serve as a member of the initial Board of Directors is as follows:

## ARTICLE IX--DISQUALIFICATION



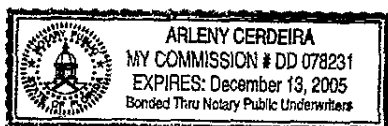
