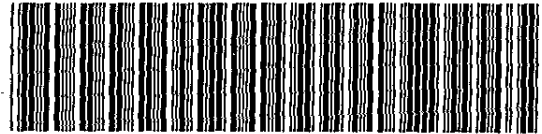

ARTICLE I
NAME

EFFECTIVE DATE

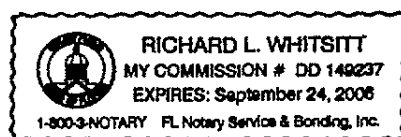

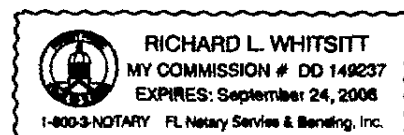


