

ARTICLES OF INCORPORATION

ARTICLE I. NAME

The name of this corporation is ARTISTIC LATH, INC.

ARTICLE II. DURATION

This corporation shall commence January 1, 2004, and shall have perpetual existence.

ARTICLE III. PURPOSE
