ARTICLES OF INCORPORATION

of

Cornish Tile, Inc.

We, the undersigned, hereby declare the purpose of forming a corporation for profit under the laws of the State of Florida.

Article I

The name of this corporation shall be: Cornish Tile, Inc.

The general nature of the business of this corporation shall be all lawful business activity permitted under the laws of the State of Florida and under the laws of the United States of America, without exception. 

Article IX


The By-Laws of this corporation may authorize issuance of both voting and non-voting series of common stock.

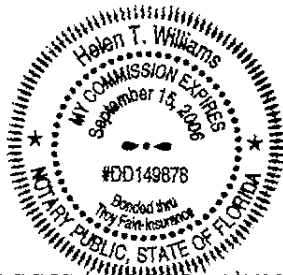
