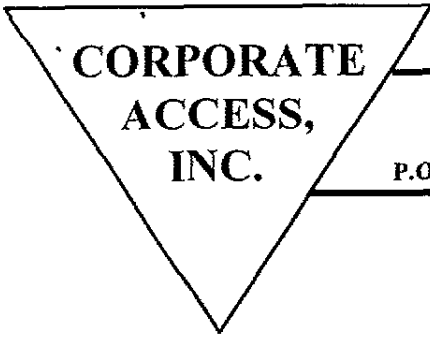

ARTICLE VIII - INDEMNIFICATION

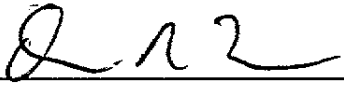
