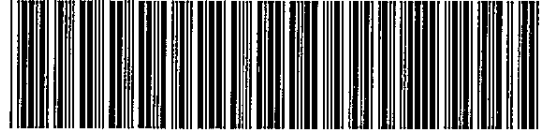

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Sunrise Trading & Industrial Supply, Inc.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE
