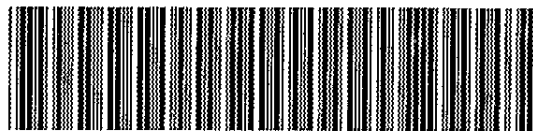



ARTICLE ONE

The name of the corporation is **CHRIS J. GJESDAL STUCCO, INC.**

ARTICLE TWO

The period of its duration is perpetual. The effective date for the corporation shall be **JANUARY 1, 2004.**

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is **One Hundred (100)** at the par value of **One Dollar (\$1.00)** each.
