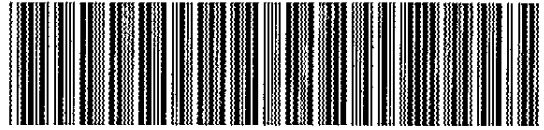



**ARTICLES OF INCORPORATION  
OF  
R & T CONCRETE, INC.**

**THE UNDERSIGNED**, acting as sole incorporator of R & T CONCRETE, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

**Name**

The name of the corporation shall be R & T CONCRETE, INC.

**Initial Board of Directors**


