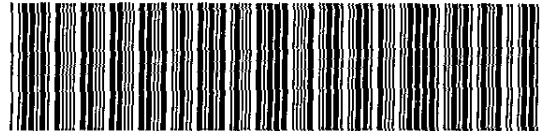

OF






