

The undersigned, acting as Incorporator of a Corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such Corporation:

ARTICLE I

The name of the Corporation is Tormay's Concrete Pumping Service, Inc.

The duration of the Corporation is perpetual.

ARTICLE X


Pre-emptive Rights to Purchase Shares
