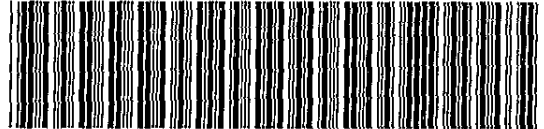



ARTICLE I

The name of this corporation is: **PANGBURN MASONRY, INC.**

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III


ARTICLE IX - BYLAWS


