ARTICLES OF INCORPORATION

OF

JOE REEDER TRUCK AND TRACTOR SERVICE, INC.

ARTICLE I

The name of this corporation is: JOE REEDER TRUCK AND TRACTOR SERVICE, INC.

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

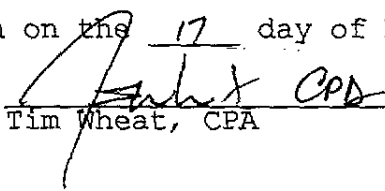
ARTICLE IX - BYLAWS

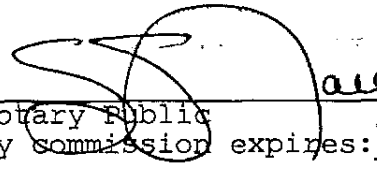

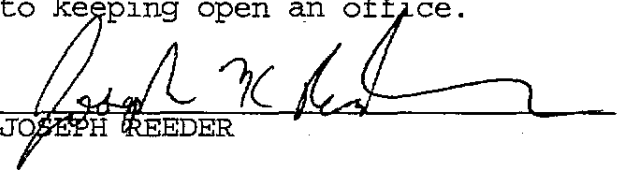
