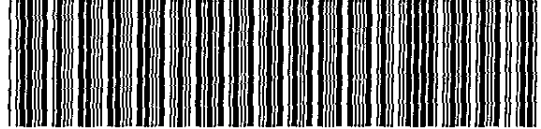



ARTICLE I. CORPORATE NAME AND PRINCIPAL ADDRESS.

The name of this corporation is: CWB INVESTMENT GROUP, INC., and the principal address is 825 Gulfview Boulevard, #105, Clearwater Beach, Florida 33767.

ARTICLE II. NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK.
