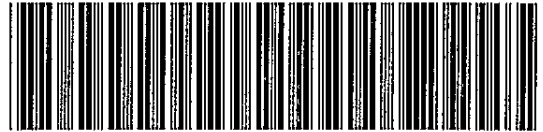

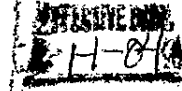

### **Article I – Name**

The name of the corporation shall be W P Peery, Inc.
