



ARTICLE I NAME

The name of the Corporation is: KEITH ECK CARPENTRY, INC., a domestic corporation which is not a member of any affiliated group.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 5621 Center Street, Wimauma, Florida 33598.

The principal mailing address of this corporation shall be: 5621 Center Street, Wimauma, Florida 33598.

ARTICLE III PURPOSE

The general purposes for which the Corporation is organized are:

- 1. To engage in the business of all phases of carpentry work; and
- 2.
