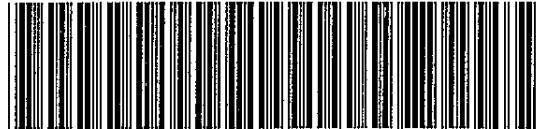

**ARTICLES OF INCORPORATION OF
V & M INSURANCE SERVICES, INC.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under Chapter 607 and/or 621 of the laws of the State of Florida.

ARTICLE I – NAME

The name of the corporation shall be **V & M Insurance Services, Inc.**

ARTICLE II – PRINCIPAL OFFICE

The principal place of business and mailing address is **1872 North Federal Highway, Boynton Beach, FL 33435.**

ARTICLE III – PURPOSE

The purpose of this corporation is to engage in every aspect of the business of providing the services of selling insurance.

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE IV – SHARES

This corporation is authorized to issue One Hundred (100) shares of One Dollar (\$1.00) par value common stock, which shall be designated as "Common Shares".

ARTICLE V – INITIAL OFFICERS/DIRECTORS

This corporation shall have one (1) director constituting the initial Board of Directors. The power to adopt, alter, amend or repeal bylaws shall be vested in the shareholders and directors.

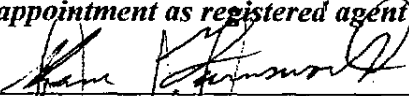
ARTICLE XI – INFORMAL SHAREHOLDER ACTION

The name and address of the Incorporator signing these articles is Vaide Mondesir, 413 NE 14th Avenue, Boynton Beach, Florida 33435.

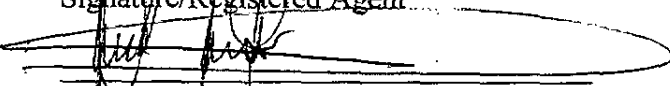
