

#### ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

#### **ARTICLE I - NAME & ADDRESS**

The name of this Corporation is **Roy T. Henry Construction**, **Inc**. The principal office, if known, or the mailing address of the Corporation is 1390 Oak Drive, Mt. Dora, Florida 32757.
