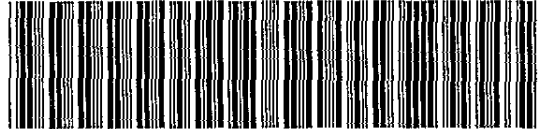

OF

ARTICLE ONE

The name of the corporation is Francisco Alvarado Framing, Inc.
