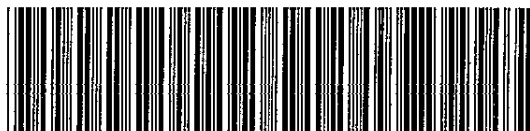

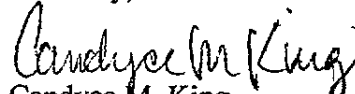

The name and address of the incorporator is William B. Knight, 7010 Mauldin Lane, Jacksonville, FL 32244.

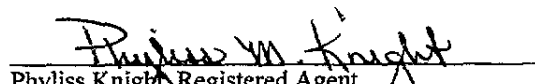
ARTICLE SEVEN
