

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

Article I

The name of the corporation is: **Jeff Darrah**, **Inc.** The principal place of business of this corporation shall be 5084 Kellchris Lane, St. Cloud, FL 34771.
