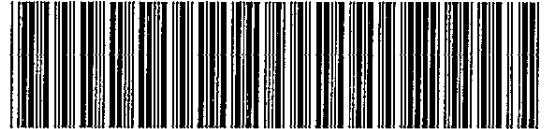

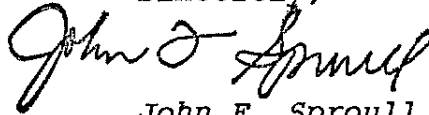

ARTICLE I - NAME

The name of the Corporation shall be STALLINGS DECORATIVE CURBS, INC.

ARTICLE II - EXISTENCE

The Corporation shall have perpetual existence and its existence shall begin business upon the approval of these Articles of Incorporation by the Secretary of State.

ARTICLE III - BUSINESS

The primary purpose of the Corporation is to engage in curb construction, however the corporation shall be permitted to engage in any other business permitted by the State of Florida and of the United States of America.

ARTICLE IV - STOCK

The Corporation shall be authorized to issue One Hundred (100) shares of stock which shall have no par value.

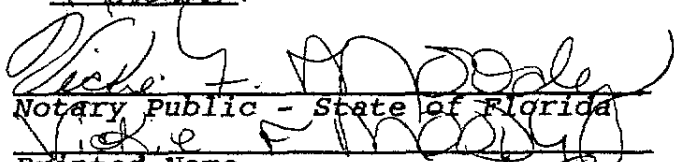
