

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

ARTICLE I

Name and Business Address

Section 1.1 Name The name of the corporation is Jerry Love Painting Inc. the address of the corporation is 9116 Adams Ave., Jacksonville FL, 32208

ARTICLE II

01-01-04

Duration

Section 2.1. <u>Duration</u>. This corporation shall exist perpetually. Corporate existence shall commence on the day of January 1, 2004 after these Articles are filed with the Secretary of State's Office.

ARTICLE III

Purposes

Section 3.1. Purposes. This Corporation is organized for the purpose of transaction any or all lawful business permitted under the Laws of the United States and of the State of Florida Specifically practicing painting & drywall construction.

ARTICLE IV

Capital Stock

Section 4.1. Authorized Capital. The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock having a par value of \$1.00 per share.
