ARTICLES OF INCORPORATION

OF

FOWLCO CARPENTRY & CABINETRY, INC.

ARTICLE I - NAME AND ADDRESS

The name of the Corporation shall be FOWLCO CARPENTRY & CABINETRY, INC.,
with its principal place of business at 5203 Northwest 61st Lane, Ocala, Florida 34482.

ARTICLE II - NATURE OF BUSINESS

This Corporation may engage or transact in any or all lawful activities or business

state, territory, country, or nation.

ARTICLE III - CAPITAL STOCK

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the Shareholders.

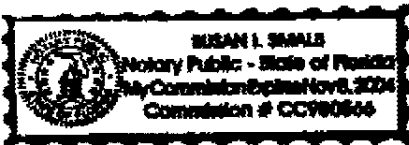
