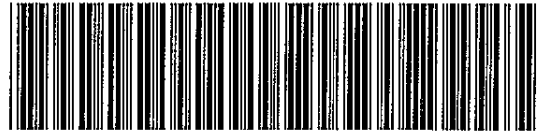

NINTH: All of the Corporation's issued stock, exclusive of treasury shares, shall be held of record by not more than thirty persons.

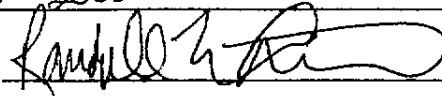
