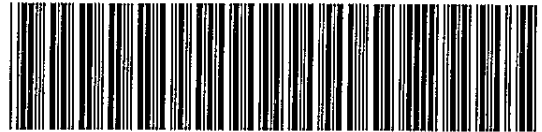

OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**EFFECTIVE DATE**

**ARTICLE 1. NAME**

The name of the corporation shall be: CRANFORD KORNER STORE , INC.






