

**ARTICLES OF INCORPORATION OF

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

**Article I**

**Name**

The name of this corporation shall be **JIM GODWIN CERAMIC TILE, INC.**

**Article II**
