
**ARTICLES OF DISSOLUTION

- SECOND:** The date the Corporation was incorporated was December 3, 2003.
- THIRD:** Adequate provision has been made for the payment and discharge of all liabilities and obligations of the Corporation.

- FIFTH:** There are no actions pending against the Corporation in any court.

- SEVENTH:** That the President or other duly authorized officer of the Corporation has been authorized and directed to file these Articles of Dissolution with the Florida Department of State in order to effectuate these Articles of Dissolution.
