

#### ARTICLES OF INCORPORATION

### THE IMAGING INSTITUTE OF PALM BEACH GARDENS, INC

The undersigned subscribers being natural persons competent of contract he the following Articles of Incorporation under the laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

#### ARTICLE I

Name: The name of the corporation is The Imaging Institute of Palm Beach Gardens, Inc.

#### ARTICLE II

Duration: This corporation shall exist perpetually.

#### ARTICLE III

<u>Purpose:</u> The purpose of this corporation is to have and exercise any and all powers necessary or convenient to effect its purpose and to otherwise engage in any lawful business permitted under the laws of the State of Florida.

#### ARTICLE IV

<u>Capital Stock:</u> This corporation is authorized to issue 10,000 shares of capital stock.

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.

#### ARTICLE V

<u>Initial Registered Office and Agent:</u> The street address of the initial registered office of the corporation is FREEMAN, MAYNOR & JONES, 1400 Centrepark Blvd, Suite 950, West Palm Beach, Florida 33401 and the registered agent is Donald J. Freeman.

The street address of the principal office of the corporation is 1710 Upland Road, West Palm

#### ARTICLE VI

Pre-Emptive Rights: Each shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the prices at which it is offered to others.

#### ARTICLE VII

Initial Board of Directors: This corporation shall have two (2) directors initially. The number of directors may be either increased or diminished from time to time by the By-Laws but shall never be less than one. The name and address of the initial directors of the corporation are as follows:

<u>By-Laws</u>: The power to adopt, alter or repeal By-Laws shall be vested in the Board of Directors and Shareholders.

#### **ARTICLE X**

<u>Indemnification:</u> The corporation shall indemnify its officers, directors and authorized agents for all liabilities incurred directly, indirectly or incidentally to services performed from the corporation, to the fullest extent permitted under Florida law existing now or hereinafter enacted.
