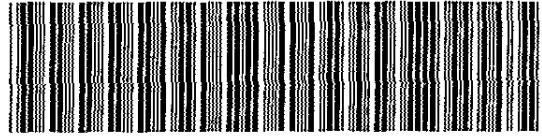

ARTICLES OF INCORPORATION  
OF  
DANIEL E. BAYS CONSTRUCTION, INC.

ARTICLE I. NAME

The name of this corporation is DANIEL E. BAYS CONSTRUCTION, INC.

ARTICLE II. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE III. TERM OF EXISTENCE

The corporation reserves the right to amend or repeal any

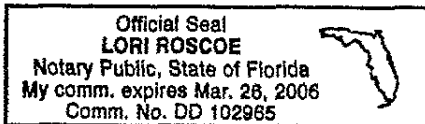
provisions in these articles of incorporation in the manner provided by law. Any right conferred on the shareholders is subject to this reservation.

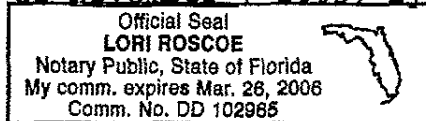
