The undersigned, for the purpose of forming a corporation for profit pursuant to Chapter 502, FLORIDA Florida statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I. CORPORATE NAME

The name of this corporation is: Fussell Express, Inc.

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III. DURATION


