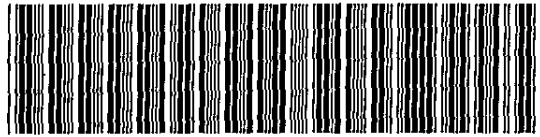

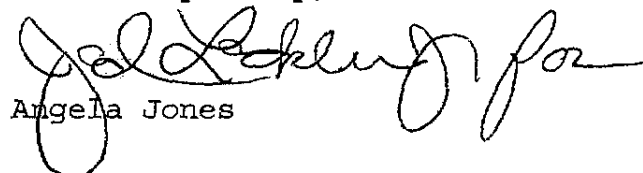

ARTICLES OF INCORPORATION

OF

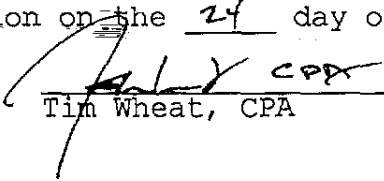
ARTICLE IX - BYLAWS

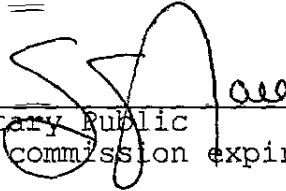
