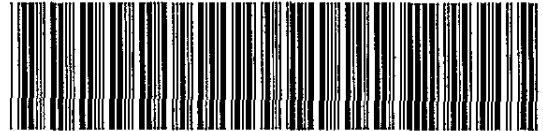

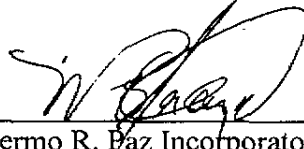
Article VI
