ARTICLES OF INCORPORATION OF

GQ'S TILE & GROUT RESTORATION, INC.

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:

ARTICLE I - NAME AND PRINCIPAL OFFICE

The name of the Corporation shall be GQ'S TILE & GROUT RESTORATION, INC., a Florida corporation. The street address of the initial principal office of the Corporation is 10955 Bristol Bay Drive, Unit 102, Bradenton, Florida 34209. The Corporation's mailing address is 10955 Bristol Bay Drive, Unit 102, Bradenton, Florida 34209.

ARTICLE II - PURPOSE AND POWERS

- Section 1. The Corporation is formed for the purpose of engaging in any lawful activity or business for which corporations may be incorporated under the laws of the State of Florida.
- Section 2. The Corporation may exercise all powers, rights and privileges conferred on corporations pursuant to the laws of the State of Florida.

ARTICLE III - DATE OF COMMENCEMENT AND TERM OF EXISTENCE

Existence of the Corporation shall commence on December 3, 2003, and shall continue perpetually.

ARTICLE IV - CAPITAL STOCK

The authorized capital stock of the Corporation shall be 1,000 shares of common stock having a par value of \$5.00 per share. The Corporation will have no other classes of shares.

ARTICLE V - BOARD OF DIRECTORS

- Section, 1. The business and affairs of the Corporation shall be managed by a Board of Directors, the members of which shall be hereinafter referred to as Directors.
- Section 2. The number of Directors shall be as provided in the Bylaws of the Corporation, but shall not be less than one (1).
 - Section 3. Directors shall be elected and hold office as provided in the Bylaws.
 - Section 4. The initial Director of the Corporation shall be Glenn A. Quesenberry.

ARTICLE VI - OFFICERS

- Section 1. The officers of the corporation shall be a President, a Secretary, and a Treasurer. Such other officers, assistant officers, and agents as may be deemed necessary may be elected or appointed from time to time as provided in the Bylaws.
- Section 2. The names of the persons who are to serve as initial officers of the corporation are:

ARTICLE VII - BYLAWS

Section 1. The Board of Directors shall adopt Bylaws for the Corporation at the first meeting of the Board of Directors following the filing of these Articles of Incorporation.

Section 2. The power to adopt, alter, amend or repeal the Bylaws of the Corporation may be exercised by the Board of Directors or the Shareholders in accordance with the provisions of the Bylaws.

Section 3. Any Bylaws adopted by the Board of Directors or the Shareholders may be altered, amended or repealed by the other group; provided, however, that any Bylaws adopted by the Shareholders may provide that it shall be altered, amended, or repealed only by the Shareholders.

ARTICLE VIII - AMENDMENTS

These Articles of Incorporation may be amended as set forth in the Florida Statutes, as amended from time to time.

ARTICLE IX - REGISTERED OFFICE AND AGENT

Section 1. The street address of the initial registered office of the Corporation shall be 10955 Bristol Bay Drive, Unit 102, Bradenton, Florida 34209.


