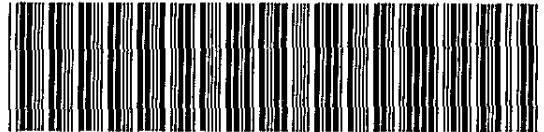

**ARTICLES OF INCORPORATION OF

I, the undersigned, hereby associate myself for the purpose of forming a corporation under the laws of the State of Florida under the corporate name of BUSTER'S U-CALL INC., and hereby set forth and declare:

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be BUSTER'S U-CALL, INC.

ARTICLE II - EXISTENCE

This corporation shall exist perpetually unless dissolved according to law.


ARTICLE VIII - BYLAWS



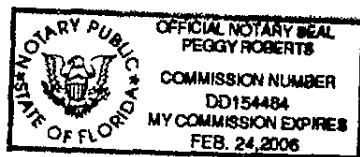
